Whereas the Founders of this Trust, out of Charitable consideration and desire of creating a Charitable Trust to carry out Charitable purpose more fully set out in the following clauses;

Whereas in pursuance of the above the founders have donated a token sum of Rs.1,001/- (Rupees one thousand and one) each.

Whereas the Board of Trustees have agreed to accept the same and own the first properties for its purposes and in the manner herein after appearing.

NOW THIS DEED OF TRUST WITNESSETH AS UNDER:

1. NAME OF THE TRUST:

The name of the Trust shall be 'SAHASRA DEEPIKA INTERNATIONAL FOR EDUCATION'

2. REGISTRATION OFFICE OF THE TRUST.

The Registration office of the Trust shall be housed in No.200, 11th Cross, Wilsongarden, Bangalore-27. However, the Board of Trustees herein may shift the registered office to such other place, as may be mutually decided upon, from time to time.

3. OBJECTS OF THE TRUST:

The Trust shall implement the following objects:

1] To construct residential schools to provide Education to orphan, homeless and needy children without any discrimination as to caste, creed, sex or nationality.

ii] To construct and maintain schools, colleges and vocational training schools to provide quality Education without any profit motive,

iii] To adopt some public schools in the backward rural areas in Karnataka, India to create a new awakening and help provide primary

education for the needy children in the rural areas.

iv] To assist needy students by extending financial assistance ~~and to assist needy students by extending financial~~ assistance ~~scholarships, and other guidance to pursue their studies.~~ *scholarships, and other guidance to pursue their studies.*

v] To arrange seminars, discussions, and other educational ~~activities~~ *opportunities for diffusion of knowledge.*

vi] To support research to find innovative approaches for the 'upbringing and motivation of neglected and homeless children to have better quality of life' in the global context.

vii] To organize a voluntary system to procure support and assistance from foreign residents of Indian origin and other Charitable Institutions for this cause.

4. The Trust created by the FOUNDERS of the Trust is not, and shall not be revocable, at the instance of the founders of the Trust at any time or under any circumstances.

5. a] The Founders of the Trust hereby constitute, nominate and appoint the Board of Trustees (Consisting of the second parties herein as the first members of the Board of Trustees) as the First Trustees.

b] The total strength of the Board of Trustees shall be not more than eleven and not less than five at any time. Besides, the first trustees may invite ~~a few~~ *persons* of eminence/donors/patrons/sympathizers/well-wishers etc., as invitees to attend the Trust meetings and shall not have any voting rights. All shall hold the office of the Trustee for a term of five years except the founders or executive Trustees.

6. The Board of Trustees shall be responsible for the maintenance of accounts, for various activities of the Trust, in accordance with the stipulations set-out herein, and for fulfilling the objects of the Trust, and conduct the affairs in accordance with the Law. The Board of Trustees may delegate all or any of the powers vested in them, the such person or persons, for such time as they deem

fit, and may revoke, vary, alter, rescind such powers so delegated.

Any way, the Board of Trustees shall be answerable for all activities of the Trust.

7. One of the Founder Trustees shall be the Executive Trustee or Chairman of the Trust. When the first Trustee ceases, the second or co-founder Trustee shall be the Executive Trustee or chairman. After the Founder Trustee ceases to be executive Trustee of the Trust, the Board of Trustees shall have the power to appoint any one among them as Executive Trustee of the Trust, and fix the duties, responsibilities, powers, period of office etc., of the person so appointed.

8. The powers vested in the Board of Trustees shall be exercised by a resolution passed at a meeting of the Board, or circulated among the members of the Board and accepted by a majority of members.

With a view to carry out the objects of the Trust, the Board of Trustees shall have the following powers:-

- a] to make donations, contributions, for promotion of the objects of the Trust.
- b] to receive any money, or other assets, in any shape or form given by any persons as gift or donation, and to hold the same as the part of the Capital fund or CORPUS OF THE TRUST.
- c] to apply and use the funds, for all or any of the objects of the Trust,
- d] to collect funds by way of donations, subscriptions, grants, or presents or endowments or otherwise,
- e] to invest funds from time to time in such securities, and in such manner, as may be deemed fit, to alter, or vary the investments, to acquire, or to sell securities, debentures, stocks and shares provided no investment would be made which violate the provisions of sections of Income Tax Act 1961.

f] to secure on lease, or by purchase, or otherwise, to

sell, mortgage, lease, or transfer in any other manner, whatsoever, the properties of the Trust, movable and immovable, to construct residential school, and other buildings and carry out other improvements thereof, for the purpose of the Trust, and manage and deal with properties.

g] to receive, collect, and realize or cause collection, or realization of all interest, dividends, bonus, that accrues that becomes due on all or any stock, funds, securities belonging to the Trust.

h] to represent the Trust, through any of the Trustees, duly authorized in this behalf in all courts, or before any authorities, any departments of the Government.

i] to open and maintain accounts of any nature in any Banks and authorize operations of the said account, by any of the members of the Board of Trustees, jointly or severally,

j] to pay out of Trust funds for salaries, wages, rent and other expenses relating to the Trust activities.

k] to do all other acts, deeds and matters and things which are necessary for carrying out the objects of the Trust.

9. Executive Trustee shall be Chairman and shall convene the Board of Trustees by serving notice of the meeting by giving at least three days clear notice. The Chairman will preside over the meetings of the Board of Trustees. In the absence of the Chairman, the vice-Chairman shall preside over the meeting.

10. The Board of Trustees shall meet from time to time, as and when necessary to transact the business of the Trust. The quorum for the meeting of the Board of Trustees shall be five. The Board shall cause the proceedings of its meetings recorded in a book.

11. The Board of Trustees shall cause true and correct accounts to be kept, of the sums of money received, and expended on behalf of the Trust. Once at least in every year, the accounts of the Trust shall be examined and correctness of the same be certified by a

Chartered Accountant and a balance sheet drawn by the said account. Which accountant is duly appointed by the Board of Trustees, and the same statement etc., shall be countersigned by all members.

12. The Board of Trustees shall have power, from time to time, to make and alter such rules and regulations with regard to the conduct of the business of the Trust, and all allied matters duly vested in them as they may deem fit.

13. The Board of Trustees shall be at liberty to add, or alter, or abrogate any of the provisions of the Trust other than the objects of the Trust.

14. The Board of Trustees shall make policy decisions and advise the members in the matters of the administration and execution of the Trust.

15. Any member of the Board of Trustees may resign and such member shall cease to be as such, upon the acceptance of his resignation.

16. The Executive Trustee named and appointed herein above, shall be executive Trustee for life. If there were to be any vacancy, either due to demise, or resignation, or due any other reason, the co-founder if any shall become the Executive Trustee for life. In case the co-founder is not willing to accept the position, the Board of Trustees is empowered to appoint a new person as a Trustee in his/her place. Such Trustee shall be a Trustee for such time as decided by the Trustees.

17. DISSOLUTION CLAUSE:- In the event of dissolution or winding up the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees, but the same shall be transferred to another Charitable Trust, society, Institution, Foundation or Association whose objects are similar to those of this.
